

Greenbuild Program Working Group Role Description

Advisory Group Position Overview

The Program Working Group (PWG) oversees delivery of educational programming intended to meet the needs of attendees to the annual Greenbuild International Conference & Expo. Members will review sessions in all rounds of review for Greenbuild, nominate and collaborate with Subject Matter Experts and liaise with session presenters. Members are required to attend the virtual Working Group retreat (tentatively **March 30th and 31st, 2022**) to determine the final education programming for Greenbuild 2023.

Responsibilities

PWG members will meet for bi-weekly conference calls **February – April** and are expected to complete the following tasks:

- **February 2:** 1st Meeting Identify important topics to guide call for proposals submissions
- **February 7 – February 24:** Review sessions in first round of review for Greenbuild.
 - Review and score on average 20 session proposals for the 1st Round
- **March 3 – March 24:** Review approx. 200 proposals in preparation for the Program Working Group retreat
- **March 30 - 31:** Attend Virtual Greenbuild Program Retreat (date subject to change)
 - Present 1-minute synopsis of session proposals that advance from the Bucket Team Round
 - Vote on all sessions to create the final Greenbuild Program
 - Identify key topic area holes in program and help develop invited sessions to fill those
 - Identify commonality in accepted sessions and develop Greenbuild Tracks
- **April:** Approve final Greenbuild Program
- **September 26 -29:** Attend Greenbuild 2023 in Washington, DC
- **October:** Final committee debrief call.

Benefits

Benefits include networking with fellow Program Working Group members, earning up to 50% of your LEED CMP continuing education hours and a **complimentary Learning Pass to Greenbuild 2023**.

Qualifications

Required

- Able and willing to consistently dedicate time to this effort including bi-weekly calls from February through May, and independent research
- Attend one virtual retreat in late-March
- Attend Greenbuild 2023 in Washington, DC

Preferred

- Previous Greenbuild Attendance
- LEED Professional Accreditation (or similar)
- LEED-certified project design, construction, operations and/or management experience
- Diverse industry conference, exposition, and event attendance
- Demonstrated knowledge of:
 - Green building best practices and strategies
 - Cutting-edge innovation and technologies
 - International trends in educational programming
 - Adult learning theory and strategies

Time Commitment

Bi-weekly conference calls from January to April. (1) 2-day virtual retreat in March 2022. In-person attendance at Greenbuild September 26-29 in Washington, DC

Advisory time is estimated at 3-12 hours per month over the time of the working group. The most significant time commitment will be February 2023 to end of April 2023.

Term Limits

Each term will be for one year. Individuals may not serve on more than one Greenbuild Advisory Group during a term year. Any one organization may not have more than one representative on any one Committee, except for federal government agencies. Additionally, individuals are limited to four consecutive years on any one Advisory Group.
